Persons who meet the below criteria and are approved by the Rottweiler Breed Council to judge General & Breed Club Open Shows.

- 1) To have five years experience owning and exhibiting in this breed and have the support of the Rottweiler Breed Council
- 2) To have judged the breed at a minimum of 7 Open Shows or Championship Shows without CCs and to have judged a minimum of 20 classes with dogs present
- 3) To have judged a minimum of 40 Rottweiler's
- 4) To have attended at least one Breed-specific Rottweiler Judging Seminar run in accordance with the relevant Kennel Club Code of Best Practice and passed an examination and/or assessment.
- 5) To have stewarded a minimum of 6 days at Open or Championship shows. (A copy of your detailed and signed stewards record book must be sent in with your application.)
